

Board of Education

Actions

The Board must have a quorum of four members to take official action. Most actions are approved with a simple majority of the members present.

Special Meetings

Special meetings are held for the purpose of conducting official school district business which needs immediate attention and cannot be postponed to the next regularly scheduled meeting, or is of such an extensive nature that it cannot be completed at a regularly scheduled meeting.

Annual Reorganization Meeting

The annual meeting for the purpose of introduction of recently elected members, reorganization of structure and election of officers is held on the first Monday of January or soon thereafter as practicable.

Public Hearings

Public hearings are scheduled for the purpose of gathering community comment and input regarding matters relating to the conduct of the school district. Action on matters on which a public hearing has been held may be taken at a subsequent regular or special meeting.

Board Meetings

The Board of Education meets regularly twice monthly on the first Wednesday (Board Meeting/Work Session) and the third Wednesday (Regular Board Meeting) unless otherwise noted. Meetings are held at 6:30 p.m. at the District Administration Office.

The Board is comprised of seven members elected to serve overlapping terms. The Superintendent of Schools serves as an ex-officio member of the Board without the right to vote. The election of Board of Education members occurs on the Tuesday after the first Monday in November during even-numbered years, and all members are elected at-large. New board members take office the first Monday in January following the election.
